- 1. Owner agrees that Tail Waggin' Ranch is not responsible for lost or damaged bedding, food or other belongings brought with dog(s).
- Owner agrees to pay rate for boarding in effect on the date of pick-up.
- 3. On the day of pick up the dog(s) must be picked up by 12:00 p.m. to avoid another day charge.
- 4. It is MANDATORY that all dogs MUST be vaccinated for animal disease such as rabies, distemper, parvovirus (DHL P.P), corona and bordetella within the time period veterinarian recommended prior to the pet entering the Kennel.
- 5. Owner agrees that the dog(s) shall not leave Tail Waggin' Ranch until all charges are paid.
- 6. By signing this contract and leaving dog(s) with Tail Waggin' Ranch, Owner guarantees that accuracy of all information given.
- 7. Tail Waggin' Ranch shall exercise reasonable care for dog(s). It is expressely agreed by the Owner and Tail Waggin' Ranch, that Tail Waggin' Ranch's liability shall in event exceed the lessor of the current charter value of a dog(s) of the same species or the sum of \$150.00 per dog boarded.
- 8. Owner agrees to be responsible for any and all acts of behavior of the dog(s), during it's stay in Tail Waggin' Ranch, any damages by dog(s) will be paid by dog(s) Owner.
- 9. Owner specifically represents that he or she is the sole owner of dog(s).
- 10. Tail Waggin' Ranch shall have and is granted a lien on said dog(s) for any and all charges resulting from boarding dog(s). The Owner agrees that in the event the boarding charges are not paid when due in accordance with the contract, Tail Waggin' Ranch may exercise it's legal right to hold dog(s) for 10 days while awaiting payment, after which pet is placed for public sale for sufficient money to cover the charges incurred. Tail Waggin' Ranch will seek legal action against the pet Owner.
- 11. If dog(s) becomes ill during stay and needs professional attention, Tail Waggin' Ranch may engage the services of a Veterinarian at Owner's expense with a \$25.00 transportation fee.
- 12. It is required that dog(s) receive the Bordetella Vaccine every six months. The Bordetella Vaccine aids in the prevention of certain strains of the Bordetella Virus., better known as "Kennel Cough". However, Tail Waggin' Ranch is not responsible for the transmission of "Kennel Cough".
- 13. Tail Waggin' Ranch is not responsible for your dog(s) acquiring diseases while staying, or any costs associated with treatment of such illness. Please vaccinate your pet!
